### RESTRICTIONS ON USE

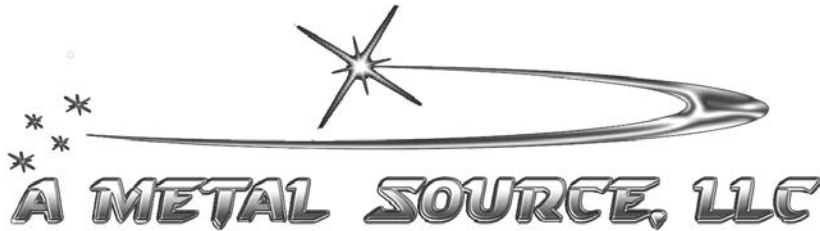

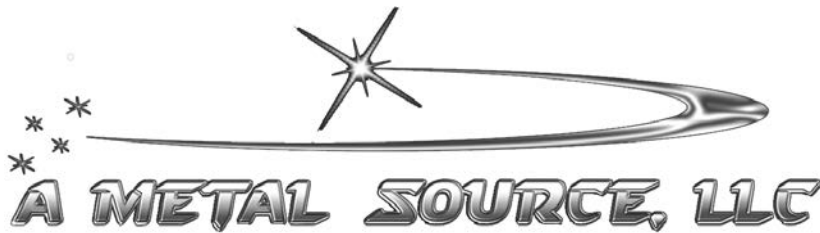

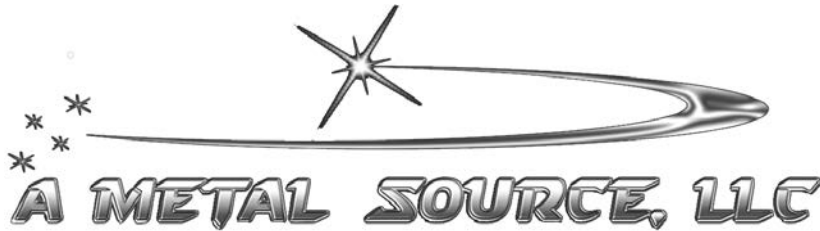
